

A NOTICE TO OUR PATIENTS

Dear Patient,

The Summa Rehab Hospital charity/discount programs apply to hospital charges only. **These programs do not apply to Physician services or professional billing fees.**

Summa Rehab Hospital will provide medically necessary rehabilitative care free of charge to qualifying individuals. To be considered eligible, you must:

- **Be a resident of Ohio**
- **Not be currently enrolled in Medicaid**
- **Be an individual or from a family whose income is at or marginally above the Federal Poverty Income Guideline listed below:**

Summa Rehab Hospital Charity Program: This program is not funded and is exclusive to Summa Rehab Hospital. Summa Rehab Hospital administration approved this program to provide medically necessary rehabilitative care free of charge to individuals from families whose household income is marginally above the Federal guideline. (Program is subject to cancellation or change at any time)

Uninsured Patient Discount Program: This program is not funded and is exclusive to Summa Rehab Hospital. Summa Rehab Hospital Board of Managers approved a sliding scale reduction on the balance due from UNINSURED patients based on household income up to 400% of the Federal guideline. Proof of household income must be submitted with application. (Program is subject to cancellation or change at any time)

To apply, please complete and sign the application on the reverse side. In order for us to process your application in a timely manner, you must provide the required information. Mail your completed application to the address below. Written notification of approval or denial will be mailed to you. If you have future services, you will be required to submit a new application.
